RULES

1. Hazardous and prohibited materials shall not be placed in the dump truck/dumpster.
2. The dump truck/dumpster shall not be overloaded.
 - a. A dump truck is overloaded when the trash/refuse rises higher than the sides of the truck bed.
 - b. A dumpster is overloaded if the lid cannot be shut.
3. It is the undersigned's responsibility to designate a suitable place on his/her property to place the dump truck/dumpster. Please note that a dump truck/dumpster will not be placed in an area where it blocks a sidewalk or roadway.
4. Undersigned shall reimburse the Town of Sykesville for any damage to the dump truck/dumpster caused by the undersigned or those working for the undersigned.
5. Once a dump truck has been placed on the undersigned's property, it shall not be operated or moved by anyone other than an employee of the Town of Sykesville. The undersigned is responsible for any damages, including injury or property damage, resulting from his/her failure to abide by this rule.

Failure to obey these rules shall result in the issuance of a citation and fine. In addition, the undersigned shall be responsible for any and all costs associated with the proper disposal of such materials. Examples of hazardous and prohibited materials include, but are not limited to, paint in liquid form, chemicals, cleaners, fuels, oils, and similar items.
